### **TERMS AND CONDITIONS**

#### **1. The Artwork**

- Must be no bigger than 1.2m wide and 1.5m high and no heavier than 10kg
- Can be vertical or horizontal.
- Any art materials or combination of art materials may be used (2D and 3D art is permitted)
- The artwork must not be offensive, racist, sexist, or violent.

#### **2. Preparing the artwork for entry**

Fill in and submit the entry form online.

Clear name and the back of the artwork with which orientation it should be displayed, along with name, and contact details. Make sure this doesn't show through to the front.

The artwork must be dropped off to the Coastline Kempsey branch by Friday, 28<sup>th</sup> June.

#### **3. Return of artwork**

You must pick up the artwork in person or nominate someone to collect on your behalf by 10th April 2023 or the art works will be disposed of.

#### **4. Exhibition**

The artwork will be displayed at our Coastline Art Hub (26 – 28 Smith Street, Kempsey NSW 2440) for the month of 3 – 28 July 2023.

## **6. Other terms and conditions**

The artwork submitted must be the original work of the entrant themselves and not infringe the copyright, moral rights, or other rights of any third party. Artworks that are deemed to not belong to or be created by the entrant will NOT be eligible.

Coastline can take no responsibility for any loss or damage to an artwork entry while in its possession.

## **7. Judging**

The judges’ decision is final, and no correspondence will be entered into.

## **8. Licensing the photograph**

Entrants (including winners and highly commended) grant Coastline non-exclusive rights to reproduce their artwork in material form, to photograph, publish and/or communicate it to the public for the following competition-related purposes, and anything incidental to such purposes, by Coastline, competition partners and sponsors: marketing, publicity, educational and publication uses for Coastline, the competition and its exhibition in all media, including but not limited to electronic/digital, broadcasting and print media, in perpetuity. Permission to so reproduce the work must be conveyed by the entrant to any purchaser of the work. Where reasonable, Coastline will attribute the artists as the author of the work and reproduce the work in full. Details of the work may be used at Coastline’s discretion. Entrants (including winners and highly commended) will not be entitled to any fee for such use.
